

Beginning with your initial contact, you'll find that our personalized service is second to none. We are readily available to assist you with information from the application process to graduation requirements.

OPEN ENROLLMENT

Begin courses at anytime and study when it best fits your schedule. At CSU, there are no predetermined semester or session dates to contend with.

SELF PACED PROGRAMS

With CSU, you can set your own pace for completing your degree program. Students are allowed 10 weeks to complete each course, but may finish a course in as little as three weeks depending on how quickly you complete the coursework. Following the required Student Orientation course, you are also given the option to complete one course at a time or two courses simultaneously.

FLEXIBLE LEARNING

Forget the days of scheduled online sessions and on-site test taking! At CSU, residency is not a requirement and coursework can be completed at times that are most convenient for you. Jamie Gauthier knows that sometimes education trumps experience. After being passed over for a position he had the experience for, but lacked the degree, he made the decision to pursue higher education.

Gauthier completed his first degree, a bachelor's degree in business administration, with CSU cum laude in 2003. He graduated from the CSU MBA program two years later with a 4.0 GPA.

Since securing his degrees with CSU, Gauthier's career has taken off. The Scotts Valley Police Department he works for offers education-based salary incentives, giving Gauthier a pay raise. He was also promoted at his department to adult detective. After earning his master's degree, he was qualified to serve as an adjunct professor for two colleges where he now develops and teaches online courses.

"I owe my academic and professional success to CSU," Gauthier said. "CSU offers high quality programs and other outstanding resources that help thousands of people around the world accomplish their educational dreams."

CSU allows maximum transfer credit for your prior academic credits, training and relevant professional licenses and certifications. Up to 75 percent of undergraduate courses and 50 percent of graduate courses can be transferred into your degree program at CSU.

EVALUATION

CSU will conduct a comprehensive evaluation of your application. Please allow at least seven to ten business days for us to provide you with a detailed evaluation report. This report will outline those courses we have determined you should take and those which we have accepted for transfer credit.

ACADEMIC CREDIT

CSU accepts transfer academic credit from institutions accredited by agencies recognized by the U.S. Secretary of Education and/or the Council for Higher Education Accreditation (CHEA). For prior undergraduate academic credit to be eligible for transfer grades earned must be a "C" or higher. However, a maximum of three courses in which a "D" was earned may be considered during the admission process. "D's" are not accepted as transfer credit for English Composition I, II or their equivalent. For prior academic credit to be eligible for transfer at the master's degree level, grades earned must be a "B" or higher. However a maximum of one course in which a "C" was earned may be considered for acceptance.

PROFESSIONAL LICENSES, CERTIFICATES, AND TRAINING PROGRAMS

CSU uses guidelines established by the American Council on Education (ACE) to determine if certain training programs, certificates, professional licenses, and/or military training warrant awarding academic credit.


TRANSCRIPT REQUEST SERVICE

- After learning of the criteria required to assemble a Prior Learning Portfolio, most students elected to take the required course instead.
- After spending a great deal of time and effort, students that did attempt to assemble a Prior Learning Portfolio became discouraged and dissatisfied when their Portfolio was rejected.

ACCELERATE YOUR FUTURE. EARN YOUR DEGREE ONLINE.

Recognized as one of the top 30 schools for military education by Military Advanced Education, more than half of students enrolled at CSU are members of the U.S. military. Completely online programs, open enrollment, flexible courses, and affordable tuition allow Servicemembers to achieve a quality education while preserving our nation's freedom.

All active-duty and retired Servicemembers receive an application fee waiver. Immediate family receives the waiver and a 10 percent tuition discount.

CSU is a member of GoArmyEd, Servicemembers Opportunity Colleges (SOC) and AU-ABC.

GOARMYED

Few other colleges and universities have been invited to participate in the U.S. Army GoArmyEd initiative that allows active duty soldiers to request TA online. This dynamic online portal automates many of the paper-based processes historically conducted with Army Education Counselors. If you are currently enrolled at CSU or are planning to apply, please visit GoArmyEd to set up your account and to learn more about how to take advantage of your TA benefits.

Servicemembers Opportunity Colleges (SOC)

SOC is a consortium of more than 1,800 colleges and universities that provide educational opportunities for Servicemembers and their families. SOC is cosponsored by the American Association of State Colleges and Universities (AASCU) and the American Association of Community Colleges (AACC) in cooperation with 13 other educational associations, the Military Services, the National Guard, and the Coast Guard.

Air University Associate-to-Baccalaureate Cooperative (AU-ABC)

CSU is one of few universities that have enrolled in the Air University Associate-to-Baccalaureate Cooperative (AU-ABC). This initiative allows Airmen to transfer at least 60 credit hours of the Community College of the Air Force (CCAF) degree into a bachelor's degree program. The accelerated program requires no more than 60 semester hours to complete a bachelor's degree with CSU and will be offered in a completely online format.

Through the AU-ABC Program, registrants who are active duty Air Force, Air Force Reserve or Air National Guard are eligible to participate in the AU-ABC Program. Prior Air Force service members who have completed their associate's degree through the CCAF are also eligible to transfer in all 60 credit hours into a bachelor's degree program. For more information, including available degree programs, please visit the Air Force Virtual Education Center on the Air Force Portal.

Military Educational Benefits

CSU is approved to offer Tuition Assistance (TA), DANTES, and Veterans Affairs (VA) benefits. Additional education funding is available to those approved for TA and eligible for MGIB-Active Duty benefits. In most cases, these benefits cover the entire cost of your program. You can complete eight undergraduate courses or six graduate courses annually without exceeding the DoD annual ceiling of \$4,500. The CSU tuition rate for undergraduate and graduate courses is below the DoD semester hour cap of \$250.

TUITION ASSISTANCE/ DANTES

Tuition assistance is available to all active duty, active Guard/Reserve, and military and civilian personnel of the Army National Guard through the Defense Activity for Non-Traditional Education Support (DANTES). Tuition assistance will cover 100 percent of tuition costs for the majority of active duty service members. Each branch of service has established an annual cap for tuition assistance.

Reserve component members are also eligible for tuition assistance under this policy. However, each service component has established specific guidelines, limits, and policies for their members that may be different than the typical active duty policy.

VA BENEFITS

Students using VA Benefits must enroll through the CSU Term Enrollment System which offers a term starting each month. Tuition is due at the time of registration and benefits will be paid directly to the student by VA. In order for CSU to process a registration for students utilizing VA/GI Bill benefits, all required forms must be submitted to VA and CSU. This will help ensure that benefits are paid in a timely manner. 

TUITION REFUND POLICY

If CSU is notified of cancellation within five calendar days of the day the enrollment agreement was signed/submitted, all money paid to CSU will be refunded. All students withdrawing after five calendar days will be charged a 20 percent registration fee. The remaining tuition will be refunded based on the course start date and the tuition percentage amounts listed below:

1st week—80% 4th week—20% 2nd week—60% 5th week—0% 3rd week—40%

CSU BOOK GRANT

Through this grant, text books are provided at no charge. CSU will automatically ship new or used textbooks to the student after processing the Per Course or Term Enrollment Agreement. If the same textbook is used in more than one course, the textbook will only be provided once. The grant covers the cost of ground domestic shipping only. Students must pay in advance for additional costs associated with other shipping options.

PAYMENT OPTIONS

Several different payment options are available including Per Course Enrollment full payment, Per Course Enrollment payment plan, Term Enrollment payment, military educational benefits, corporate direct billing, credit based loans, or Federal Financial Aid.

FEDERAL FINANCIAL AID

Federal Financial Aid offers grant and loan programs administered by the U.S. Department of Education. CSU

participates in the following grant and loan programs.

FEDERAL GRANTS

Pell Grants—Undergraduates Only

Pell grants are awarded solely on demonstrated financial need to every eligible undergraduate student who hasn't already earned a bachelor's or professional degree.

Academic Competitiveness Grant (ACG)—1st and 2nd Year Undergraduates Only—The ACG is a need and merit based grant that does not need to be repaid.

National Science and Mathematics Access to Retain Talent Grant (SMART)—3rd & 4th Year Undergraduates Only—The National SMART Grant program is a need and merit based program intended to encourage students to enroll in college majors in physical, life, and computer sciences; engineering; technology; mathematics; and certain foreign languages.

FEDERAL LOANS

Federal Family Education Loans—

The U.S. Department of Education administers the Federal Family Education Loan program which generally consists of Stafford loans (for students) and Parent Loan for Undergraduate Students (PLUS) loans (for parents).

Stafford Loans—Stafford loans are available both as subsidized and unsubsidized loans.

PLUS Loans—Undergraduates Only

— Federal PLUS loans enable parents with good credit histories to borrow money to pay the educational expenses of their children.

Graduate PLUS Loans— A graduate PLUS loan is a non-need credit based loan similar to a private student loan, but with the benefit of having a fixed interest rate and federal guarantee.

At Columbia Southern University, we have an open admission policy. Applications and enrollment are accepted throughout the calendar year.

ADMISSION REQUIREMENTS

Requirements for admission into our degree programs include:

Undergraduate Programs—High School Diploma or GED
Master Degree Programs—Accredited Bachelor's Degree
Doctoral Program—Accredited Master's Degree in Business and Two Years of
Experience in a Business Related Field

Applicants who are citizens of a country where English is not the primary language are required to submit one of the following prior to admission:

Test of English as a Foreign Language (TOEFL)

A minimum of 500 in the paper-based version, 173 in the computer-based version, or 61 in the internet-based version of the TOEFL is required for admission.

International English Language Testing System Exam (IELTS)

A minimum of 61 in the internet-based test or a Band 5 or higher on the IELTS.



Getting Started



Fitting an education into your already busy schedule is not easily done, but it is possible. Our completely online programs are designed with the flexibility you need to fit your education around career and family commitments. You can begin at anytime and study at a pace that best fits your lifestyle.

ENROLLMENT

CSU offers two convenient enrollment systems:

Per-Course/Open Enrollment (10 Week Courses)

The CSU Per-Course Enrollment System allows students to begin a course at any time. There are no predetermined semester or session dates. Students may take one course after another or multiple courses simultaneously.

Term Enrollment (8 Week Courses)

Students using Federal Financial Aid or VA Benefits must use the Term Enrollment System. Courses must be completed within 8-weeks, have set start and end dates, and are cohort based. All students in the course will start the course together and proceed through the course on the same timeline.

Students must submit discussion board postings and other assignments by the weekly due date. You can enroll in one or multiple courses during each eight week term.

TEMPORARY STATUS

Even if we are still missing copies of the transcripts we need to complete your evaluation, you can enroll immediately under "Temporary" Admissions Status. As a "Temporary" student, you may complete up to 13 undergraduate credit hours or 7 graduate credit hours. Once all official transcripts are received and evaluated, an Application Evaluation Report will be issued and your status will be changed.

STUDENT RESOURCES Online Library

Our Online Library provides a wide variety of information through full-text journal articles, select reference tools, over 30,000 full-text online books, and more. Available 24/7, the Ask an Online Librarian service answers your questions at any time. Your one-time library fee is \$20 for undergraduate and graduate level students, and \$50 for DBA students.

STUDENT ORIENTATION (required)

ur general education curriculum is designed to give students a broad spectrum of the classes offered at CSU. It provides a well-rounded education with classes ranging from technical writing to calculus.

General education courses may be taken simultaneously with program courses. Required general education courses can be completed through CSU, the CLEP examination, or transfer credit.

To meet the number of required electives for a degree program, any of the general education undergraduate 2000 or 3000 level courses can be used provided they are not included in the requirements of the degree program.







CERTIFICATE TRANSFER INFORMATION

Students who complete an undergraduate/graduate certificate program through CSU may transfer those courses into a degree program with the corresponding concentration. Similarly, students enrolled in a degree program with a concentration, may transfer the concentration courses into the corresponding certificate program. The fee for processing this transfer and certificate is \$150. To request this transfer, you must complete the "Degree to Certificate Transfer Request" form on the CSU website.

If you request a transfer for a certificate program (four courses), you may continue to complete the remaining three courses of the concentration to qualify for an Advanced Certificate. A separate "Degree to Certificate Transfer Request" must be submitted for the Advanced Certificate.

No transfer credit is accepted into certificate programs. All courses must be completed as required by the certificate.


