* Course Equivalencies/General Notes:

- To receive eligible credit, the final FCSO completion certificate or training log confirming completion of the Basic Law Enforcement Training Course must be submitted.
- Program Elective application is dependent upon program director approval and is only possible in multiples of three credits.
